Communication by e-mail takes the place of written communication. It is the user's responsibility to keep the e-mail address up to date and to check it regularly for information.

THIS AGREEMENT CONSISTS OF 15 ARTICLES AND CONSTITUTES EVIDENCE BY ALL KINDS OF ADMINISTRATIVE, OFFICIAL AND UNOFFICIAL PERSONS AND INSTITUTIONS FOR THE USE OF SERVICE EXCHANGE BETWEEN THE PARTIES. SIGNING THE AGREEMENT BY THE PARTIES MEANS ACCEPTANCE OF EACH OF THE ITEMS. OTHERWISE, THE CLAIM CANNOT BE CLAIMED OR PROVED, EXCEPT TO THE TOOLS OF PROOF STATED IN THE TBK, TMK, HMK AND RELEVANT LEGISLATION.
